Mobile Home Requirements

Prior to Mobile Home being placed within the City Limits of Greensboro the following criteria's must be met:

- (1) Application must be completed.
- (2) A witness or notarized written statement of permission to place mobile home on said property (if applicant does not own property)
- (3) A copy of the said property deed
- (4) Site Plan/Plot Plan
- (5) Picture of Mobile Home (if used)
 - If Mobile Home is located within city limits, the code enforcer will make a visit to the site.
- (6) Mobile Home must be cleaned of all debris.
- (7) Mobile Home must have service pole for electric hook up.
- (8) Mobile Home must have water and sewer connection.

Within thirty (30) days the following requirements must be met:

- (1) Mobile Home must be (if applicable) painted, install siding and/or roof repaired.
- (2) Mobile Home must have underpinning/skirting.
- (3) Mobile Home must have front & back steps (48 inches wide with 7in. rise and 11in. tread) with hand rails.
- (4) Mobile Home Tags/Sticker must be purchased from Tax Collector's Officer and displayed next to the front door.
- (5) Mobile Home must have Driveway connection to street.
